SEBI has, vide the Circular No. <u>SEBI/HO/MIRSD/MIRSD RTAMB/P/CIR/2021/655</u> dated November 3, 2021 read with clarificatory SEBI Circular No. <u>SEBI/HO/MIRSD/MIRSD RTAMB/P/CIR/2021/687</u> dated December 14, 2021 and SEBI Circular No. <u>SEBI/HO/MIRSD/MIRSD RTAMB/P/CIR/2022/8</u> dated January 25, 2022, as an on-going measure to enhance the ease of doing business for investors in the securities market has mandated furnishing of the following by holders of physical securities:

- PAN
- 2. Address with PINCODE
- 3. Email address
- 4. Mobile number
- 5. Bank account details
- 6. Nomination and
- 7. Specimen signature.

Folios wherein any one of the cited documents / details are not available on or after April 01, 2023, shall be frozen by the Registrars and Transfer Agent of the Company (RTA)

Investors are requested to ensure the above details are updated with KFin Technologies Private Limited (KFin Tech) RTA of the Company before April 1, 2023, since folios for which the above details are not available thereafter shall be frozen.

SEBI has prescribed the following forms to furnish the details required to KFin Technologies Private Limited by the physical securities holders:

6	Compulsory Linking of PAN with AADHAAR (i.e., Valid PAN) – by March 31, 2022 SEBI has advised investors to link their PAN with their AADHAAR number by March 31, 2022 or any other date, as may be specified by the Central Board of Direct Taxes ('CBDT'). The folios in which PAN(s) is/are not valid as on the notified cut-off date of March, 31, 2022, shall be frozen. Transposition please note that after the process of the above request henceforth the issue of securities will be in dematerialized form only.
